

ENVIRONMENTAL POLICY

The commitment of Alpiq Energía España SAU (hereinafter Alpiq or the Company) regarding the environmental performance of all its operations is a fundamental part of its Company Project and takes precedence over the achievement of the rest of its business objectives, with the sole exception of possible conflicts with the preservation of the Health and Safety of people, if any.

This commitment is set out in the following principles:

- Alpiq will base its environmental management system on a circular economy model, making the best use of resources, so that for the production of its products or provision of its services, the consumption of raw materials, water and energy sources is reduced, in line with the objectives of the Paris Agreement.
- Consideration of the environmental variable in decision making, both strategic and operational.
- A sustainable and responsible use of resources will be made, ensuring reuse and recycling where possible.
- The activities linked to the maintenance and improvement of the environmental performance of our operations will be reflected in the Company's Management System, so as to ensure that they are perfectly integrated in the development of daily activities.
- All management measures to be adopted will be based on continuous improvement, risks will be periodically assessed, appropriate plans will be deployed, objectives and targets will be set, and compliance will be measured.
- Compliance with current environmental legislation and other applicable requirements will be ensured, as well as continuous adaptation to the environmental regulatory framework.
- Sufficient training on environmental monitoring aspects will be provided to both Alpiq employees and collaborating companies, disseminating the principles contemplated in this policy. Alpiq will also publish information on its environmental performance in a proactive manner and will collaborate with the competent bodies and administrations.
- Alpiq will promote environmental communication, both externally and internally, in a transparent manner and will collaborate with the competent authorities.
- Alpiq will work to prevent pollution and reduce environmental impacts throughout the value chain, by training employees and encouraging their involvement as well as that of collaborating companies and interested parties.
- The purpose of this policy is to establish a reference framework for integrating the protection of nature and the environment into the company's strategy, investments and operations, and to define the principles of action for environmental and natural capital management.
